2. Tuition Refund Schedule

Students who officially withdraw from a course or program may be eligible for a partial tuition refund according to the following schedule:

During Week 2	50% tuition refund
During Week 3	25% tuition refund
After Week 3	No refund

Application and registration fees are non-refundable in all cases, except when the Academy cancels the program.

3. Withdrawal Process

To be eligible for any tuition refund, students must submit a **written withdrawal request** to the Administration Office. The effective date of withdrawal will be the date the written request is received.

4. Non-Participation

Failure to attend classes, complete assignments, or participate in coursework does **not** constitute an official withdrawal. Students who do not formally withdraw will remain responsible for all tuition and fees and will not be eligible for a refund.

5. Program Cancellation

If Florida Theological Chaplaincy Academy cancels a course or program for any reason, students will receive a **full refund of all tuition and fees paid**.



6. Transfer of Tuition

In certain circumstances, students may request that paid tuition be transferred to a future course or program session rather than receiving a refund. Such requests are subject to administrative review and approval.

7. Special Circumstances

Requests for exceptions due to medical emergencies, family crises, military obligations, or other extenuating circumstances may be considered on a case-by-case basis. Supporting documentation may be required.

8. Refund Processing

Approved refunds will be processed within 7 to 14 business days after approval and will be issued using the original payment method whenever possible.

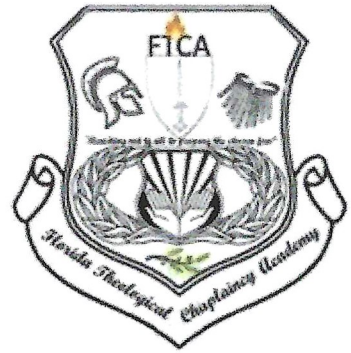

By the Spirit of the Lord I Stand to Command My Morning Prayer

I decree and declare my day with divine assignments. I have the power for change in my mouth. The power for prosperity, for health, successful ministry, marriage, business, relationships, and whatever I need this day is in my mouth. I greet this day with anticipation of great things happening for me, in me, around me, and with me.

1. By the word of God and by the Holy Spirit that lives, moves, and has its being in me, I stand to command my morning, and I declare it is a great day.
2. I decree and declare that a new day is dawning for my ministry, finances, relationships, health, and for my business ventures.
3. Old things have passed away; behold, all things have become new this day. I maximize my potential and move boldly toward my destiny. I decree and declare that new cycles of victory, success, and prosperity will replace old cycles of failure and poverty.
4. I pray for the family life of my boss and supervisors, that they will come into a stronger faith in You. I pray for their social life, that they might balance work and home life in healthy ways. I pray for their spiritual life, that they partner with and support worthy causes in our community as You prosper them in business.

5. Lord God, let the seven-fold manifestations of Your Holy Spirit be upon me this day. The spirit of wisdom, understanding, counsel, might, knowledge, the fear of the Lord, and prophetic insight fill me this day.

13. I decree and declare: I am gaining new territories: new emotional, intellectual, business, spiritual, ministerial, and financial territories.

14. I download success, prosperity, health, wealth, focus, discipline, productivity, balance, vision, direction, ingenuity, creativity, spirituality, holiness, righteousness, peace, joy, and resourcefulness into my day.

15. Lord God, let me have clarity of mind as You have called me to be a visionary. I will not fall prey to prideful thoughts, arrogance, or disobedience this day.

16. Father, help me to be an example for those who do not know You. Lord, let Your presence be known today in the midst of the work environment and let Your spirit fill every cubicle or whatever space You want to occupy. Help me to be mindful that You call me to treat others as I want to be treated according to Matthew 7:12.

17. I release the law of dispossession. Every satanic demonic squatter that is on the land or property that belongs to me, I command you to go in the name of Jesus. By Him, I run through troops and leap over walls. I am more than a conqueror! God is my God of breakthroughs. (2 Samuel 5:20)

29. Holy Spirit, give me new ways of living; grant me better strategies; upgrade me with Kingdom technology and Kingdom methodology. I receive the supernatural discipline to implement them today.

30. I am excited; my spirit is ignited: I walk in favor with God, who gives me divine favor with man. As You guide, I chart new courses; as You inspire and empower, I invent new products, goods, and services.

31. My emotions are sound and stable. I am celebrated, not tolerated, loved by all who come into contact with me. I seek divine opportunities and occasions to help others succeed.

32. I decree and declare the Lord is my partner. I work according to His daily agenda. I work smarter, not harder. I am an entrepreneur who provides jobs and work

opportunities for others. Father, allow only those with divine assignments to be drawn to me.

33. Supernatural God, bless the works of my hands. Grant me the ability to do the extraordinary.
